Extended Abstract (Arial, 11pt, Bold)

The body of your extended abstract begins here. The extended abstract should be a summary of your presentation, including problem, aims, methods, scope, findings, and conclusions of the study.

Extended abstract, in between min 750 – max 1000 words, includes the following:

Introduction: In the introductory part of the study, a conceptual/theoretical framework should be established related to the subject of the study. In this framework, especially the studies that are directly related to the subject and purpose of the study should be summarized. It should be clearly explained why the current/ongoing study is important in this sense, what gap it will fill in the literature, and what additional contribution it can provide.

Aim: The aim of the study should be clearly stated. Accurate information should be given to the reader about which question the study seeks to answer, which research question or questions it is based on, and why this study is necessary.

Scope: The scope of the study should be stated in an understandable way.

Limitations: The limitations of the study, the target audience or the field of study considered in the implementation and completion of the study should be specified in an understandable way.

Methodology: The methodology should be clearly stated. The basic approach used for the research, the main matrix, the paradigm, method and tool of data collection, scales, and why the chosen method(s) are suited for the problem should also be included.

Findings: The findings of the research should be given clearly in the abstract. Results or findings reached in the analysis of the data or conceptual studies should be discussed in relation to the conceptual/theoretical framework. Authors are expected to evaluate the similarities and differences and their reasons. For the researches that final findings are not revealed yet; expected, or estimated findings and comments and evaluations regarding them should be included. If permission has been obtained from the institution or ethics committee related to the research, this information should be included in the summary. The responsibility for this issue belongs to the author(s).

Conclusion and recommendations: The result or results of the research should be stated. In this part of the abstract, important issues related to the conceptual/theoretical framework and considered as contributory to the relevant literature should be included, depending on the findings of the research that has been concluded or ongoing. After mentioning the expected benefits of the study, recommendations for practitioners and/or researchers should be presented.

Abstracts file name must be Author Surname.pdf

For abstracts with more than one authors, files should be named as: First Author Surname – Second Author Surname.pdf

All the abstracts must be uploaded via congress website as **pdf format**.

In order to be published in the extended abstract book, all papers should be:

- written in a clear and understandable English
- revised according to the reviewers' comments (if any) as forwarded to the corresponding author(s),
- formatted properly according to the guidelines,
- submitted on time according to the deadlines,
- presented according to the announced programme,

References (Arial, 10pt, Bold)

References must appear in complete accordance with latest version of APA Style Referencing Guidelines in <http://www.apastyle.org/> including upper and lower case and punctuation rules. The in-text citation must identify the cited work by surnames of authors and date of publication between parentheses. Citing quoted verbatim text from another source must include page numbers.

Please avoid using scientific or engineering symbols, acronyms, and bullets. It should be typed single-spaced line in 10pt Arial.

References must be listed alphabetically and for same authors chronologically (Bentley et al., 1929).
